# Juvenile Justice Federal Funding Chart: Breakdown of Title V



Beginning in FY 2017, Congress has earmarked funding under Title V for specific programs, thus limiting the use of funds. This is despite the fact that the Act was intended to give localities control over funding for delinquency prevention programming, tailoring programs to best meet the needs of their young people.

The Juvenile Justice Reform Act of 2018, which reauthorized the Juvenile Justice and Delinquency Prevention Act, significantly expanded what programs qualify to receive funds, allowing for a broader, more holistic approach to addressing the needs of young people. While the final appropriations bill for FY 2020 does contain earmarks for Title V funding, for the first time in several years, \$14.5 million remains unearmarked, thus opening up the funding for all authorized purposes.
